

## RESOLUTION NO. 98-09

A RESOLUTION OF THE CITY OF DESTIN, FLORIDA, RELATING TO COMMUNITY REDEVELOPMENT; APPOINTING THE DESTIN CITY COUNCIL AS THE DESTIN COMMUNITY REDEVELOPMENT AGENCY BOARD OF DIRECTORS; ESTABLISHING THE LIFESPAN OF THE AGENCY; ESTABLISHING A MECHANISM FOR CREATING A COMMUNITY REDEVELOPMENT ADVISORY COMMITTEE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Resolution No.98-08, the City Council of the City of Destin has made a finding of necessity for the creation of the Destin Community Redevelopment Agency; and

WHEREAS, Florida Statutes, Chapter 163 (Part III), prescribes the creation of a community redevelopment agency; and

WHEREAS, upon the adoption of a resolution by the City Council declaring the need for a Community Redevelopment Agency, the City Council may, by resolution, appoint itself as the board of directors of the Community Redevelopment Agency; and

WHEREAS, the City Council, acting as the Community Redevelopment Agency, may enlist the help of citizen advisory committees to assist in carrying out the duties of the Community Redevelopment Agency.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Destin, Florida that:

SECTION ONE. That the City Council declares itself to be the Destin Community Redevelopment Agency, and that the City Council are thus appointed as the members of the Destin Community Redevelopment Agency, as provided for in Chapter 163.357(1)(a) (F.S.).

SECTION TWO. That the City Council establishes the Destin Community Redevelopment Agency for a period of 30 years, to be funded by tax increments or other methods allowed by Chapter 163, Part III (F.S.).

SECTION THREE. It is further resolved that the powers of the Community Redevelopment Agency shall be those as described Chapter 163 (Part III), Florida Statutes, or as amended from time to time.

SECTION FOUR. That the Community Redevelopment Agency may appoint, upon nomination, members from certain City Advisory Boards and Committees, and from the general public to serve as the advisory committee to the Destin Community Redevelopment Agency, said committee to be known as the Community Redevelopment Agency Advisory Committee.

SECTION FIVE. This resolution shall take effect immediately upon approval by Council and signature of the Mayor.
